

1. Student Withdrawal Policy

On completion of fee payment process, the candidate will be considered as a provisionally admitted student. All provisionally admitted students **MUST** report to the campus for the Orientation program, attend the classes and occupy the allotted hostels (if applicable). If a provisionally admitted student wishes to withdraw from the program, the timelines & process are as follows

- In case of Sl. No. 3 of Table 1, Withdrawal approval and refund process will be initiated only after the receipt of hard copy of the application submitted by the Candidate / Parent / Authorized Representative (in person) at the Admissions Office. Fees shall be refunded to an eligible student within Forty-Five days from the date of receipt of hard copy of the application. The candidates are NOT eligible for any refund of fee (Program Fee + Hostel Fee) if the Candidate / Parent / Guardian does not physically report to the Admissions Office on or before **31 October 2026**.

- In case of Sl. No. 3 of Table 1, the candidate will have to get the Clearance /No dues from all the concerned departments of the Institute even if the candidate has not reported /joined the Institution. If the withdrawal request is submitted on or after the Orientation Program / Class Commencement Date (whichever is earlier) submission of duly completed **Dues Clearance Certificate** (obtained from the respective College office) is **MUST**.
- In case of programs with Online Counseling process, the above-mentioned criteria is applicable on submission of Withdrawal request under the Online Counseling portal.

In case, if the Candidate is **NOT** able to physically report to the campus for Withdrawal process,

- An authorization letter issued by the Candidate is mandatory. [Click here](#) for the format.
- Parent / Guardian **MUST** report to the campus with the following
 - Withdrawal Application Form generated from MAHE Portal
 - Authorization letter signed by candidate and Parent/ Guardian
 - Any one (01) of the Government issued Original ID card of self & Candidate, and one set of photocopies. The original ID Card will be returned after verification
 - Emails / Photocopies of the Application form, Authorization letter, Photo ID proof will **NOT** be accepted at any circumstances.

2. Allotted Seat Cancellation Policy

On completion of the admission process, all admitted students **MUST** report to the campus for the Orientation program, start attending the classes and occupy the allotted hostels (In case of hostelite).

- The admitted candidates may also report to the campus, one (01) or two (02) days prior to the orientation and occupy the hostels. This will help to acclimatize better

MAHE is at liberty to cancel the allotted seat, as below and policy on cancellation of admission of admitted students is as follows

On Cancellation of the admission the candidate must proceed with the Withdrawal option. Fees shall be refunded (if any) as per **Table No. 1** mentioned above to an eligible student within *Forty-Five* days from the date of receipt of hard copy of the application.

3. Program Fee Refund Amount

For the candidates who have strictly followed the above-mentioned instructions, the Program Fee refund would be processed as mentioned below. *The refund rules mentioned below, are NOT applicable for NEET based / PhD admissions*

- Any student who withdraws from the Program as mentioned in No. 2 of Table 3 will be required to remit to the University, in addition to the amount already forfeited, the Program fee payable for the remaining period of the program
- All refunds will be processed as per the above table by the MAHE Student Finance Office based on the recommendation of the Director (Admissions)
- In case of Foreign / NRI / NRI Sponsored candidates, the refund will be made in accordance with RBI / foreign exchange regulations after deducting USD 250 applicable for Sl. No. 1 of Table 3. As mentioned in Sl. No. 2 of Table 3, there is 100% fee deduction. Rules with regard to Hostel fees refund will be as per Table 1.
- Application and Entrance Test fees once paid shall NOT be refunded under any circumstances.
- The above refund rule information is indicative only and the University reserves the right to make changes as per the notifications received from the statutory / regulatory authorities concerned from time to time. Any changes made in the above will be updated in the website
- Requests for withdrawal via email / telephone / SMS / Whatsapp or any other medium outside of MAHE portal will NOT be considered.
- Program fees shall be strictly **non-refundable** and **forfeited** in instances of proven charges of indiscipline, involvement in substance abuse, or any conduct bringing disrepute to the Department, Institution, or the University
