  - Candidates receiving a scholarship from any other source are not eligible to apply for a scholarship from MAHE
    - In case of violation, MAHE scholarship will be cancelled, and paid scholarship will have to be refunded back to MAHE
- All scholarship eligible students are required to apply for the scholarship via MAHE Scholarship Application Form, made available on completion of the admission process.
- All the Scholarship schemes are governed by the policies and regulations of Manipal Academy of Higher Education (MAHE).
  - In the event of any dispute, the decision of MAHE shall be final.

### 1.1 Scholarships & Rank Range

- **Eligibility**
  - 80 % aggregate of Physics + Chemistry + Biology (as per eligibility criteria) in 10+2 from a recognized board
- **Scholarship**
  - This scholarship involves 100 % waiver of Program fee and Hostel fee
    - However, Candidates are required to pay the full first (1<sup>st</sup>) year program fee including Refundable Caution Deposit of Rs. 10,000 at the time of Reporting / completing the admission formalities
      - After due verification, the list of students eligible for Kalam - Pai scholarship will be finalised within 1 month after the completion of all rounds of Counseling.
      - The excess fee paid (after applying the scholarship) shall be refunded within 2 months of completion of all rounds of Counseling, only on submission of duly filled MAHE Scholarship Application Form 2026 to the Admissions office

- However, Rs. 10,000 would be retained as the minimum fee payable, in addition to the refundable caution deposit.
    - Kalam – Pai scholars are required to pay minimum Rs. 10,000 towards the Program fee every year, for the subsequent years.
  - Hostel Allotment
    - The Kalam – Pai scholar will have to accept the Hostel allocation (Double attached, non-AC) by MAHE
      - In case the Kalam – Pai scholar opts for upgradation of hostel (if available), he / she is required to pay the differential hostel fee.
  - Sustenance Allowance
    - Rs. 5,000 per month will be given to the Kalam – Pai scholar as sustenance stipend, at the end of each month, for the entire regular duration of the program on campus (excluding the internship period).
  - The Kalam – Pai scholar **MUST** take care of other expenses like food, books, and other academic material requirements
- **Process**
    - Kalam – Pai scholarship will be offered to the candidate with topmost NEET All India Rank meeting the above-mentioned criteria, who complete the Reporting & Admission formalities in the first round of DGHS / MCC Counseling.
      - In case of Upgradation / Resignation by this Candidate (as per MCC Guidelines), this scholarship will be awarded to the round 1 admitted candidate with next best rank (meeting the above-mentioned criteria) in the same Institution.
      - In case of scholarship vacancy after considering the admitted student of round 1, scholarship will be awarded to the candidate based on NEET All India Rank, after completion of all rounds of counselling.
    - Candidates admitted through Government category (KEA Counseling, JCECEB Counseling) are **NOT** eligible for this scholarship
  - **Subsequent Years**
    - Award of scholarship for the subsequent years will be same as given at the time of admission in the first year
    - Continuation of scholarship for subsequent years will be based on academic performance of the student in the University examinations preceding the due date for payment of fee / dues i.e., Minimum cumulative aggregate of **65%** marks in a system of awarding marks.
      - Students who are promoted to next year with less than 65% aggregate marks are **NOT** eligible for scholarship and **MUST** pay the full Program fee applicable for that academic year.
      - Students who are promoted to next year with failures (F) / Incomplete (I) / Detention (DT) grades, are **NOT** eligible for scholarship and **MUST** pay the full Program fee applicable for that academic year
  - **Forfeiture / Reimbursement of Scholarship**
    - Scholarship will be forfeited in the instances of irregularity in attendance, proven charges of indiscipline, bringing disrepute to the Department / Institution / University etc.
    - As the Institute / University does **NOT** have the provision to fill the vacant seat after the last date applicable for resignation as per DGHS / MCC timeline, if the Kalam - Pai scholar resigns / withdraws from the course, he / she **MUST** reimburse the total Program fee (all fee instalments) applicable for

entire duration as per Prospectus 2026 + Hostel fee + Sustenance stipend, received for the years of scholarship utilized, back to MAHE Manipal, before leaving the program.

### 1.3 Freeship

#### • Eligibility

- 80% aggregate of Physics + Chemistry + Biology (as per eligibility criteria) in 10+2 from a recognized board

#### • Scholarship

- The Freeship involves 100 % waiver of the program fee payable
  - However, Candidates are required to pay the full first year program fee including refundable Caution Deposit of Rs. 10,000 at the time of Reporting / completing the admission formalities.
    - After due verification, the list of students eligible for Freeship will be finalised within 1 month after the completion of all rounds of Counseling.
    - The excess fee paid (after applying the scholarship) shall be refunded within 2 months of completion of all rounds of Counseling, only on submission of duly filled MAHE Scholarship Application Form 2026 to the Admissions office.
      - However, Rs. 10,000 would be retained as the minimum fee payable, in addition to the refundable caution deposit.
    - Freeship scholars are required to pay minimum Rs. 10,000 towards the Program fee every year, for the subsequent years.
  - The Freeship scholar **MUST** take care of other expenses like accommodation, food, books, and other academic material requirements

#### • Process

- The scholarship will be offered to the candidate with topmost NEET All India Rank meeting the above-mentioned criteria, who complete the Reporting & Admission formalities in the first round of DGHS / MCC Counseling.
  - In case of Upgradation / Resignation by this Candidate (as per MCC Guidelines), this scholarship will be awarded to the round 1 admitted candidate with next best rank (meeting the above-mentioned criteria) in the same Institution.
  - In case of scholarship vacancy after considering the admitted student of round 1, scholarship will be awarded to the candidate based on NEET All India Rank, after completion of all rounds of counselling.
- Candidates admitted through Government category (KEA Counseling, JCECEB Counseling) are **NOT** eligible for this scholarship

#### • Subsequent Years

- The award of scholarship for the subsequent years will be same as given at the time of admission in the first year.
- Continuation of scholarship for subsequent years will be based on academic performance of the student in the University examinations preceding the due date for payment of fee / dues i.e., Minimum cumulative aggregate of 65% marks in a system of awarding marks.
  - Students who are promoted to next year with less than 65% aggregate marks are **NOT** eligible for scholarship and **MUST** pay the full Program fee applicable for that academic year.
  - Students who are promoted to next year with failures (F) / Incomplete (I) / Detention (DT) grades, are **NOT** eligible for scholarship and **MUST** pay the full Program fee applicable for that academic year

- **Forfeiture / Reimbursement of Scholarship**

- Scholarship will be forfeited in the instances of irregularity in attendance, proven charges of indiscipline, bringing disrepute to the Department / Institution / University etc.
- As the Institute / University does **NOT** have the provision to fill the vacant seat after the last date applicable for resignation as per DGHS / MCC timeline, if the Freeship scholar resigns / withdraws from the course, he / she **MUST** reimburse the total Program fee (all fee instalments) applicable for entire duration as per Prospectus 2026, received for the years of scholarship utilized, back to MAHE Manipal, before leaving the program.

#### **1.4 Scholar**

- **Eligibility**

- 80% aggregate of Physics + Chemistry + Biology (as per eligibility criteria) in 10+2 from a recognized board

- **Scholarship**

- The Scholar scholarship involves 50% waiver of the program fee payable
  - However, Candidates are required to pay the full first year program fee including refundable Caution Deposit of Rs. 10,000 at the time of Reporting / completing the Admission formalities.
    - After due verification, the list of students eligible for Scholar scholarship will be finalised within 1 month after the completion of all rounds of Counseling.
    - The excess fee paid (after applying the scholarship) shall be refunded within 2 months of completion of all rounds of Counseling, only on submission of duly filled MAHE Scholarship Application Form 2026 to the Admissions office.
- The Scholar awardee **MUST** take care of other expenses like accommodation, food, books, and other academic material requirements

- **Process**

- The scholarship will be offered to the candidate with topmost NEET All India Rank meeting the above-mentioned criteria, who complete the Reporting & Admission formalities in the first round of DGHS / MCC Counseling.
  - In case of Upgradation / Resignation by this Candidate (as per MCC Guidelines), this scholarship will be awarded to the round 1 admitted candidate with next best rank (meeting the above-mentioned criteria) in the same Institution.
  - In case of scholarship vacancy after considering the admitted student of round 1, scholarship will be awarded to the candidate based on NEET All India Rank, after completion of all rounds of counselling.
- Candidates admitted through Government category (KEA Counseling, JCECEB Counseling) are **NOT** eligible for this scholarship

- **Subsequent Years**

- The award of scholarship for the subsequent years will be same as given at the time of admission in the first year.
- Continuation of scholarship for subsequent years will be based on academic performance of the student in the University examinations preceding the due date for payment of fee / dues i.e., Minimum cumulative aggregate of 65% marks in a system of awarding marks.
  - Students who are promoted to next year with less than 65% aggregate marks are **NOT** eligible for scholarship and **MUST** pay the full Program fee applicable for that academic year.

- Students who are promoted to next year with failures (F) / Incomplete (I) / Detention (DT) grades, are **NOT** eligible for scholarship and **MUST** pay the full Program fee applicable for that academic year
- **Forfeiture / Reimbursement of Scholarship**
  - Scholarship will be forfeited in the instances of irregularity in attendance, proven charges of indiscipline, bringing disrepute to the Department / Institution / University etc.
  - As the Institute / University does **NOT** have the provision to fill the vacant seat after the last date applicable for resignation as per DGHS / MCC timeline, if the scholar resigns / withdraws from the course, he / she **MUST** reimburse the total Program fee (all fee instalments) applicable for entire duration as per Prospectus 2026, received for the years of scholarship utilized, back to MAHE Manipal, before leaving the program

- **Forfeiture / Reimbursement of Scholarship**
  - Scholarship will be forfeited in the instances of irregularity in attendance, proven charges of indiscipline, bringing disrepute to the Department / Institution / University etc.
  - As the Institute / University does **NOT** have the provision to fill the vacant seat after the last date applicable for resignation as per DGHS / MCC timeline, if the scholar resigns / withdraws from the course, he / she **MUST** reimburse the total Program fee (all fee instalments) applicable for entire duration as per Prospectus 2026, received for the years of scholarship utilized, back to MAHE Manipal, before leaving the program.

  - Manipal Institute of Technology (MIT) Manipal

- This scholarship is to support meritorious students from the economically under-privileged sections of the Society

#### 3.1 Scholarship Guidelines

- **Eligibility**
  - Schooling
    - Candidates who have studied any 3 years of schooling (Std 1 – 12) in any State / Central Government School / PU Colleges within India, are only eligible
      - Candidates who have studied in Government Aided / Unaided schools / Private Schools are **NOT** eligible
  - Academic Performance
    - **70%** aggregate of Mathematics + Physics + Optional subject (as per selection criteria) in 10+2 from the recognized Board
- Manipal Entrance Test (MET)
  - Candidates **MUST** have appeared in Manipal Entrance Test (MET) 2026
  - Candidates **MUST** participate in B.Tech Common Counseling process by paying Rs. 10,000 as a waitlist deposit
- Family Means / Income
  - Family (Father + Mother) Gross income should be less than **Rs. 12 lakhs** for the Financial Year 2025 – 26
- **Top 40** students (approximate) meeting the above-mentioned criteria are eligible for this scholarship.
- List of documents required
  - Candidate's 10<sup>th</sup> standard marks card / grade sheet
  - Study Certificate issued by the Govt school
    - Confirming that the candidate has studied any 3 years of schooling (Std 1 – 12) in any State / Central Government School / PU Colleges within India
  - Copy of 12<sup>th</sup> std marks card / grade sheet (Physics + Mathematics + Optional paper)
    - Proving he/she has scored a minimum aggregate of 70% marks in the above-mentioned subjects
  - Financial Statement for 2025 -26
    - Detailed Statement of Income of Father & Mother for the Financial Year 2025 – 26
    - IT Returns Acknowledgement of filing

#### 3.2 Harish and Bina Shah Foundation (HBSF) – MAHE EduEmpower Scholarship

- **Scholarship**
  - This scholarship involves **100 %** waiver of Program fee, Hostel fee & Mess Charges.
- **Process**
  - The Scholarship seats will be allotted to the candidates with the topmost MET rank, meeting the above-mentioned criteria in the **first round** BTech common Counseling.

- In case of scholarship vacancy after considering the admitted student of round 1, scholarship will be allotted to the candidates based on MET rank meeting the above-mentioned criteria in subsequent round(s) of Counseling.
  - In case of non-joining / withdrawal during subsequent rounds, scholarship will be awarded as per merit (MET rank) who is meeting the above-mentioned criteria.
  - After due verification, the list of students eligible for HBSF-MAHE scholarship will be finalized and MAHE Admissions Office will email the MAHE Scholarship Application Form 2026 to the eligible candidates.
  - The excess fee paid (Rs. 10,000) shall be refunded within 3 months, only on submission of duly filled Scholarship Application Form 2026 to the MAHE Manipal / Bengaluru Admissions office.
  - Hostel
    - HBSF - MAHE scholar will be allotted a Double attached non-AC / any other type of hostel room by MAHE.
  - Candidates admitted under this category will have to take care of other expenses such as books and other academic material requirements etc.
- **Subsequent Years**
    - The award of scholarship for the subsequent years will be same, as awarded during year 1.
      - Scholarship will be extended in the subsequent year only to those students who have cleared all subjects in the University Examinations of the previous year before the due date for payment of annual program fee.

- **Forfeiture / Reimbursement of Scholarship**
    - In case the HBSF-MAHE scholar leaves the course before the course completion (for any reason), he / she **MUST** reimburse the full Program fee (as per Prospectus 2026) for the years of scholarship utilized, back to MAHE Manipal.
    - Scholarships will be forfeited in instances of irregularity in attendance, proven charges of indiscipline, bringing disrepute to the Department / Institution / University etc

- 60% aggregate of Mathematics + Physics + Optional subject (as per selection criteria) in 10+2 from the recognized board

###### **• Scholarship**

- The scholarship involves **30%** of the Program fee payable
  - Candidates are required to pay the full 1<sup>st</sup> year program fee including Refundable Caution Deposit of Rs. 10,000 at the time of seat allotment / before the deadline specified for payment of full 1<sup>st</sup> year fee
  - In case of upgradation
    - From current (listed above) to any other branch other than the above-mentioned 3, the student **MUST** reimburse the scholarship amount availed during 1<sup>st</sup> year back to MAHE
      - In case of upgradation from the current (listed above) to any other branch,
        - Student will forfeit the scholarship
        - Fee applicable to the upgraded branch will apply
      - From any other branch to the branch listed above, the student will be eligible for the scholarship for that academic year provided the academic performance is 7 CGPA & above, with no backlogs.
  - Candidates admitted will have to take care of other expenses such as hostel accommodation, food, books etc

###### **• Process**

- After due verification, the list of students eligible for scholarship will be finalized and MAHE Admissions Office will email the MAHE Scholarship Application Form 2026 to the eligible candidates.
- The excess fee paid (after applying the scholarship) shall be refunded within 3 months, only on submission of duly filled Scholarship Application Form 2026 to the MAHE Manipal Admissions office

###### **• Subsequent Years**

- Award of scholarship for subsequent years will be the same as awarded during 1<sup>st</sup> year provided the student continues her studies in any one of the above-mentioned 3 branches.
- Continuation of scholarship for subsequent years will be based on the academic performance in the immediate previous university examinations before the due date for payment of fee / dues i.e., minimum CGPA of 7 in a 10-point grading system.
  - Scholars, who are promoted to next year with the following, are **NOT** eligible for scholarship and **MUST** pay the full Program fee applicable for that academic year
    - Less than 7 CGPA
    - Failures (F) / Incomplete (I) / Detention (DT) grades, are **NOT** eligible for scholarship

- **Forfeiture / Reimbursement of Scholarship**

### 5.1 Scholarship Guidelines

- **Eligibility**
  - 80% aggregate of Mathematics + Physics + Optional subject (as per selection criteria) in 10+2 from the recognised Board.
- **Academic Performance**
  - Minimum 8 CGPA & above, with no backlogs in Semester 1 of BTech program.
  - Merit list will be prepared after the declaration of re-evaluation results of regular end semester examination.
- **Scholarships**
  - Freeship & Scholar category scholarships put together, constitute 5% of the GENERAL category intake for each branch (out of 5%, scholarship seats are distributed in a ratio of 80:20 between MET Rank and JEE Mains Rank based admissions) and are applicable for the entire program duration, starting 1st year of the program.

  - Candidates admitted under Freeship category will have to take care of other expenses such as hostel accommodation, food, books etc
- **Process**
  - Scholarships will be offered to the candidate with topmost MET rank in the respective branch who complete the admission formalities in the **first round** BTech common Counseling.
    - In case of withdrawal / upgradation during subsequent rounds, scholarship will be awarded as per merit (MET rank) to Round 1 admitted candidates (same branch / upgraded from other branch) in the same Institution and as per scholarship vacancy after completion of all rounds of counselling (Except Spot Admission).
    - *In case of scholarship vacancy after considering the admitted students of Round 1 (same branch / upgraded from other branch) in the same Institution, this scholarship(s) will be awarded to the candidate(s) based on MET rank after completion of all rounds of counselling.*
  - After due verification, the list of students eligible for Freeship scholarship will be finalized and MAHE Admissions Office will email the MAHE Scholarship Application Form 2026 to the eligible candidates.
  - The excess fee paid (after applying the scholarship) shall be refunded within 1 month of commencement of 2nd semester, only on submission of duly filled Scholarship Application Form 2026 to the MAHE Manipal Admissions office and only to those students who are able to score Minimum 8 CGPA & above, with no backlogs in Semester 1 of BTech program.
    - However, Rs. 10,000 would be retained as minimum fee payable in addition to the refundable caution deposit.
  - Freeship scholars are required to pay minimum Rs. 10,000 towards the Course fee every year, for the subsequent years
- **Subsequent Years**
  - The award of scholarship for the subsequent years will be same, as awarded during 1<sup>st</sup> year

- Continuation of scholarship for subsequent years, will be based on academic performance of the students at the University examinations preceding the due date for payment of fee / dues i.e. Minimum CGPA of 8 in a 10-point grading system.
  - Freeship scholars, who are promoted to next year with less than 8 CGPA, are **NOT** eligible for scholarship and **MUST** pay the full Course Fee applicable for that academic year.
  - Freeship scholars, who are promoted to next year with failures (F) / Incomplete (I) / Detention (DT) grades, are **NOT** eligible for scholarship and **MUST** pay the full Course Fee applicable for that academic year
- **Forfeiture / Reimbursement of Scholarship**

### 5.3 Scholar

  - Candidates are required to pay the full 1<sup>st</sup> year course fee including refundable Caution Deposit of Rs. 10,000 before the deadline specified for payment of full 1<sup>st</sup> year fee.
  - Candidates admitted under the Scholars category will have to take care of other expenses such as hostel accommodation, food, books etc
- **Process**
  - Scholarships will be offered to the candidate with topmost MET rank in the respective branch who complete the Reporting & Admission formalities in the first round BTech common Counseling.
  - In case of withdrawal / upgradation during the counseling rounds, scholarship will be awarded as per merit (MET rank) to round 1 admitted candidates (same branch / upgraded from other branch) in the same Institution as per scholarship vacancy after completion of all rounds of counselling.
    - *In case of scholarship vacancy after considering the admitted students of round 1, this scholarship(s) will be awarded to the candidate(s) (same branch / upgraded from other branch) in the same Institution based on MET rank after completion of all rounds of counselling (except spot admission).*
    - In case of change of branch at the beginning of second year, the “Scholar” scholarship will be forfeited, and candidate **MUST** pay the full program fee for that and subsequent years.
  - After due verification, the list of students eligible for Scholar scholarship will be finalized and MAHE Admissions Office will email the MAHE Scholarship Application Form 2026 to the eligible candidates.
  - The excess fee paid (after applying for the scholarship) shall be refunded within 3 months, only on submission of duly filled Scholarship Application Form 2026 to the MAHE Manipal Admissions office only to those students who are able to score Minimum 8 CGPA & above, with no backlogs in Semester 1 of BTech program
- **Subsequent Years**
  - Award of scholarship for the subsequent years will be same as awarded during year 1.
  - Continuation of scholarship for subsequent years will be based on the academic performance in the immediate previous university examinations before the due date for payment of fee / dues i.e., minimum CGPA of 8 in a 10-point grading system.

- Scholar scholars, who are promoted to next year with less than 8 CGPA in the immediate previous academic year are **NOT** eligible for scholarship and **MUST** pay the full Program fee applicable for that academic year.
- Scholar scholars, who are promoted to next year with failures (F) / Incomplete (I) / Detention (DT) grades, are **NOT** eligible for scholarship and **MUST** pay the full program fee applicable for that academic year.

● **Forfeiture / Reimbursement of Scholarship**

- Scholarships will be forfeited in instances of irregularity in attendance, proven charges of indiscipline, bringing disrepute to the Department / Institution / University etc.
- In case the Scholar leaves the course before the course completion (for any reason), he / she **MUST** reimburse the full program fee (as per Prospectus 2026) for the years of scholarship utilized, back to MAHE Manipal.

**5.4 Achiever**

- “Achiever” Scholarship constitutes Top **5 %** of the general category intake
  - Excluding Freeship & Scholar scholarship students for each branch
  - Is applicable at the beginning of the 2<sup>nd</sup> year, 3<sup>rd</sup> year and 4<sup>th</sup> year based on the annual academic performance of the immediate previous year i.e., 1<sup>st</sup> year, 2<sup>nd</sup> year and 3<sup>rd</sup> year respectively.
  - Transfer students are **NOT** eligible for this scholarship in the year of admission
    - Based on performance, they will be eligible for 3<sup>rd</sup> & 4<sup>th</sup> year scholarship, as per guidelines
- The Achiever scholarship involves **20 %** waiver of the program fee

- Minimum **annual academic performance** requirement to become eligible for this scholarship is 8 CGPA with no backlogs
- In the case of students with the same annual CGPA, the tie will be broken using the following criteria
  - No. of subjects with maximum number of A+ /  $\geq 90\%$  of marks
  - No. of subjects with maximum number of A /  $\geq 80\%$  marks
  - Student with highest aggregate marks
  - Student with best aggregate attendance percentage
- There will be **NO** scholarship based on the performance in the final year.
- The Candidates admitted under Achiever category will have to take care of other expenses such as hostel accommodation, food, books etc.

● **Forfeiture / Reimbursement of Scholarship**

- Scholarships will be forfeited in instances of irregularity in attendance, proven charges of indiscipline, bringing disrepute to the Department / Institution / University etc.

    - Aggregate of 80 % or 8 CGPA, (as per admission criteria) in 12<sup>th</sup>
  - Postgraduate (PG) program
    - Aggregate of 70 % or 7 CGPA, in Undergraduate (UG)
  - Candidate's Father / Mother should be currently serving in / retired from & drawing military pension / served in and has laid down their life in the line of duty; the organizations listed in section 6.1
  - Details / Documentation Requirements
    - Recommendation Letter from the respective authorities (section 6.1), stating that the candidate is meeting the above criteria
- **Process**
  - On completion of the application process, Candidates have to approach the respective authorities for the issue of Recommendation letter.
    - The authorities **MUST** issue a Letter of Recommendation (LOR) mentioning the following details
      - MAHE Application No
      - Name of the Candidate

    - The candidate has to submit the LOR along with other documents at the time of admission.
  - Candidate will participate in the selection of the program applied for & as per eligibility

- Selection will be as per merit and defined admission process
- On receipt of the offer letter
  - Candidate has to confirm the same by making full fee payment
- University will decide the candidates eligible for the scholarship based on merit and inform the candidate, via email.
- **Process**

- Merit Scholarship is applicable for the entire program duration, starting 2<sup>nd</sup> year of the program i.e., year of admission.
- The Bonafide Certificate mentioning the period of study (ALL 3 years / 6 semesters) issued by the College / Institute should be produced at the time of admission.

### **7.2 Merit Scholarship**

- The scholarship involves **75 %** waiver of the Program fee payable.
  - Candidates are required to pay the full first year program fee including Refundable Caution Deposit of Rs. 10,000 at the time of Admission.

  - The excess fee paid (after applying for the scholarship) shall be refunded within 3 months, only on submission of duly filled Scholarship Application Form 2026 to the MAHE Manipal Admissions office
- **Subsequent Years**
  - The award of Merit scholarship for the subsequent years will be same as given at the time of admission in the first year.
    - Scholarship will be extended in the subsequent year only to those students who have cleared all subjects in the University Examinations of the previous year before the due date for payment of annual program fee
- **Forfeiture / Reimbursement of Scholarship**
  - Students who are promoted to next year with failures (F) / Incomplete (I) / Detention (DT) grades, will **NOT** be eligible for scholarship for that academic year.
  - The scholarships will be forfeited in the instances of irregularity in attendance, proven charges of indiscipline, bringing disrepute to the Department / Institution / University etc.
  - In case the Merit scholar leaves the course before the course completion (for any reason), he / she **MUST** reimburse the total program fee (as per Prospectus 2026) for the years of scholarship utilized, back to MAHE Manipal.

  - **Freeship & Scholar** category Scholarships put together constitute **5 %** of the general category intake and are applicable for the entire program duration, starting the from 1<sup>st</sup> year of the program.
  - **Achiever** category Scholarship constitutes **5 %** of the general category intake (excluding Freeship & scholarship students) and is applicable from the beginning of 2<sup>nd</sup> year, 3<sup>rd</sup> year and 4<sup>th</sup> year based on the annual academic performance in the immediate previous year i.e., 1<sup>st</sup> year, 2<sup>nd</sup> year and 3<sup>rd</sup> year
  - There will be **NO** scholarship based on the performance in the final year.

  - After due verification, the list of students eligible for Freeship scholarship will be finalized and MAHE Admissions Office will email the MAHE Scholarship Application Form 2026 to the eligible candidates.
  - The excess fee paid (after applying for the scholarship) shall be refunded within 3 months, only on submission of duly filled Scholarship Application Form 2026 to the MAHE Manipal Admissions office.
    - However, Rs. 10,000 would be retained as the minimum fee payable in addition to the refundable caution deposit.

  - Less than 8 CGPA, are **NOT** eligible for scholarship
    - **MUST** pay the full Program fee applicable for that academic year.

- **Forfeiture / Reimbursement of Scholarship**

- After due verification, the list of students eligible for the scholarship will be finalized and MAHE Admissions Office will email the MAHE Scholarship Application Form 2026 to the eligible candidates.

    - If the candidate has paid the full fee, the excess fee paid (after applying for the scholarship) shall be adjusted towards subsequent year fees, only on submission of duly filled Scholarship Application Form 2026 to the MAHE Manipal Admissions office.
- **Subsequent Years**
  - The award of scholarship for the subsequent years will be same as awarded during year 1.
  - Continuation of scholarship for subsequent years will be based on the academic performance in the immediate previous university examinations before the due date for payment of fee / dues.
  - Scholarship will be extended in the subsequent years only to those students who have cleared all subjects in the University Examinations of previous year before the due date for payment of annual program fee.
  - Scholars, who are promoted to next year with failures (F) / Incomplete (I) / Detention (DT) grades,
    - Are **NOT** eligible for scholarship
    - **MUST** pay the full Program fee applicable for that academic year.
- **Forfeiture / Reimbursement of Scholarship**
  - Scholarships will be forfeited in instances of irregularity in attendance, proven charges of indiscipline, bringing disrepute to the Department / Institution / University etc.
  - In case the Scholar leaves the course before the course completion (for any reason), he / she **MUST** reimburse the full Program fee (as per Prospectus 2026) for the years of scholarship utilized, back to MAHE Manipal.

### 22.3 Admissions through SII / COMPEX / ICCR etc

MAHE Manipal also admits Foreign nationals through Study in India (SII), COMPEX (Embassy of India Nepal), Indian Council of Cultural Relations (ICCR) etc., with a subsidized fee structure.

- Such students are **NOT** eligible for this scholarship.

### 23. Scholarship for Konkani Speaking Students

MAHE awards 10 % fee waiver of program fee as scholarship, to candidates admitted to Undergraduate (UG) and Postgraduate (PG) programs **ONLY**, whose mother tongue is Konkani.

#### 23.1 Scholarship Guidelines

- Applicable for Students admitted under **GENERAL** category only.
- The candidate is required to go through the admission process specified for each program
- There are **NO** preferential / reserved seats for Konkani speaking students.
- The fee waiver is **10 %** of the program fee.
- The candidate will have to take care of other expenses such as hostel accommodation, food, books, etc.
  
- **Process**
  - On allotment, candidates are required to pay the full first year program fee + Rs. 10,000 refundable Caution Deposit at the time of reporting.
  - Candidates **MUST** submit the following documents
    - Letter from the passing out School Principal / Institute Director certifying that mother tongue is Konkani.
    - Filled up MAHE Scholarship Form 2026 available in the MAHE Manipal Admissions Office.
  - The excess amount paid (after applying the scholarship) shall be refunded after the commencement of 2<sup>nd</sup> semester, only on submission of duly filled Scholarship Application Form 2026 to the Director (Student Affairs) office MAHE.
  
- **Subsequent Years**
  - Fee Waiver for the subsequent years will be same as given at the time of admission in the first year
    - Fee Waiver will be extended in the subsequent year only to those students who have cleared all subjects in the University Examinations of the previous year before the due date for payment of annual program fee.
    - Students who are promoted to next year with failures (F) / Incomplete (I) / Detention (DT) grades, will **NOT** be eligible for fee waiver for that academic year.
  
- **Forfeiture / Reimbursement of Scholarship**
  - The fee waiver will be forfeited in the instances of irregularity in attendance, proven charges of indiscipline, bringing disrepute to the Department / Institution / University etc.
  - In case the candidate leaves the course before the course completion (for any reason), he / she **MUST** reimburse the total program fee (as per Prospectus 2026) for the years of scholarship utilized, back to MAHE Manipal.

## 24. Merit Scholarship for Children of MAHE Manipal Alumni

MAHE awards merit scholarships to all students admitted under the **GENERAL** category, for all undergraduate (UG) and postgraduate (PG) full time programs, whose father **OR** mother has studied (Full Time) and graduated from any of the MAHE Manipal Institutions (refer **Annexure C**).

### 24.1 Scholarship Guidelines

- This is **NOT** applicable to
  - MD, MS, MDS, DM, M.Ch programs
- Applicable for Students admitted under **GENERAL** category only.
- The candidate is required to go through the admission process specified for each program
  - There are **NO** preferential / reserved seats for children of MAHE Manipal Alumni.
- The fee waiver is **10 %** of the program fee.
- The candidate will have to take care of other expenses such as hostel accommodation, food, books, etc.
- Scholarship would be provided to maximum of 2 children only.
  
- Eligibility
  - Undergraduate (UG) program
    - **80 %** aggregate (as per admission criteria) in 12<sup>th</sup>
  - Postgraduate (PG) program
    - **70 %** aggregate in Undergraduate (UG)
  - Candidate's Father / Mother should have studied & graduated in any of the following, from any one of the MAHE Manipal institutions (refer **Annexure C**)
    - UG program (of minimum 3 years)
    - PG program (of minimum 2 years)
    - Super Specialty (of minimum 2 years)
    - Ph.D. program (including part time)
  - The Parent(s) have to register under Alumni portal (<https://manipalalumni.manipal.edu/>) before submission of the Scholarship application.
  
- Documentation
  - The following **MUST** be submitted, along with the application, to the Admissions Office
    - Proof of Registration in the MAHE Alumni portal.
    - Provide Father's / Mother's Education qualification details
      - like Roll No, Program etc. at the time of applying, by submitting / uploading all year / semester mark cards
      - OR
      - Degree certificate.
    - Submit / Upload any one of the Government Photo ID proof like Aadhaar, PAN Card, Passport, Driving License of the parent.
  
- Process
  - On allotment, candidates are required to pay the full first year program fee + Rs. 10,000 refundable Caution Deposit at the time of reporting.
  - The excess fee paid shall be refunded after the commencement of the 2<sup>nd</sup> semester, only on submission of duly filled Scholarship Application Form 2026 to the MAHE Manipal Admissions office.
  
- Subsequent Years

- Award of scholarship for the subsequent years will be same as given at the time of admission in the 1<sup>st</sup> year.
- Scholarship will be extended in the subsequent year only to those students who have cleared all subjects in the University Examinations of previous year before the due date for payment of annual program fee.
- Students who are promoted to next year with failures (F) / Incomplete (I) / Detention (DT) grades, will **NOT** be eligible for fee waiver for that academic year.
- **Forfeiture / Reimbursement of Scholarship**
  - Fee Waiver will be forfeited in the instances of irregularity in attendance, proven charges of indiscipline, bringing disrepute to the Department / Institution / University etc.
  - In case the candidate leaves the course before the course completion (for any reason), he / she **MUST** reimburse the total program fee (as per Prospectus 2026) for the years of scholarship utilized, back to MAHE Manipal.

## 25. Scholarship Scheme of Interest Subsidy on Education Loan for MAHE Students

MAHE Manipal offers interest subsidy on education loan as scholarship, to the eligible students who joined various Undergraduate (UG) and Postgraduate (PG) programs offered at MAHE.

The scholarship is in the form of providing '**Interest subsidy**' by partial reimbursement of the interest on education loan availed by them from banks.

### 25.1 Scholarship Scheme Guidelines

This scholarship scheme is applicable to the following category of students only.

- The eligible loan for interest subsidy shall be the amount equivalent to the accumulated program fee already paid by the student to MAHE for the respective academic years.

  - Loan shall be availed from a nationalized / scheduled bank for payment of program fee prescribed for the course.
    - Loan availed for payment of repeat term (casual term) fee will **NOT** qualify for the scheme.
- Filled up application form along with loan documents **MUST** be submitted to Director Admissions office for verification & eligibility check
- The fee shall be reduced by the subsidies (if any) provided by MAHE, in the form of fee concessions as per the Table below.

## 26. AICTE TFW (for BTech) and PG Scholarships

All India Council for Technical Education (AICTE) New Delhi awards scholarships for deserving & meritorious students.

### 26.1 AICTE Tuition Fee Waiver (TFW) Scheme for Bachelor of Technology (B.Tech) Students

AICTE has introduced the scheme on tuition fee (program fees include tuition and other fees) waiver for economically weaker students, enrolled in the

#### 26.1.1 AICTE Tuition Fee Waiver (TFW) Guidelines

- The proposed scheme will be applicable **ONLY** to the students with parents' annual income (from all sources) less than Rs. 8 lakhs (or as specified by AICTE) for the Assessment year 2026 – 27.
- AICTE TFW seats will **NOT** exceed 5% of the General intake for each branch.
- Candidates with MET 2026 rank will be communicated separately regarding the process of applying for AICTE TFW scheme.
- The AICTE scholarship will cover only the tuition fee payable for the particular course of study and will **NOT** cover the expenses such as hostel accommodation, books, etc.

  - If the parent(s) are working abroad, they **MUST** submit the following
    - Copy of the 12 month's salary slip (April 2025 to March 2026)
    - Copy of Passport
    - Copy of Employment Visa
- After due verification, the list of students eligible for AICTE TFW will be communicated to all the candidates via email for participation in online counseling.
  - On seat allotment in any round, candidates are expected to confirm the allotted seat within the timeline by paying the stipulated fee.

#### • Subsequent Years

- The fee waiver awarded for the 1<sup>st</sup> year will remain the same for the subsequent years.
  - Students who are promoted to next year with failures (F) / Incomplete (I) / Detention (DT) grades, will **NOT** be eligible for fee waiver for that academic year.
  - Fee Waiver will be forfeited in the instances of irregularity in attendance, proven charges of indiscipline, bringing disrepute to the Department / Institution / University etc.

#### • Forfeiture / Reimbursement of Scholarship

- As the number of scholarship has been considered based on the intake of the particular BTech branch, if any student changes the branch in the second year, then he / she is **NOT** eligible for continuation of the scholarship from 2<sup>nd</sup> year onwards.
